

N/USD remained flat to close the week at N502/\$.

**Investors & Exporters Foreign Exchange (IFEX) Window:** Naira depreciated marginally against the Dollar to close the week at N410.80/\$ representing 0.01% depreciation from the previous week's N410.75/\$.





- The 180 days rate inclined by 0.34% to close at 14.94% p.a. from previous week's 14.60% p.a




